AGREEMENT

THIS AGREEMENT entered into this _	, day of,
20, between Planned Parenthoo	d Golden Gate, a non-profit corporation of
California located at 2211 Palm Ave, S	San Mateo, California (hereinafter referred to as
PPGG) and Sutter Medical Center of S	anta Rosa, 3325 Chanate Road, Santa Rosa,
California, 95404 (hereinafter referred	d to as the Hospital).

WITNESSETH:

- 1. The Hospital will accept all referrals from PPGG's location in Rohnert Park for emergency treatment at any time of the day or night where such emergencies arise out of procedures administered by PPGG for its patients in Sonoma County, California including Health Centers located at Rohnert Park, CA or other health centers as the need may arise.
- 2. The Hospital will accept all referrals from PPGG for obstetrical care in light of the fact that these services are no longer provided by PPGG. Patients with both low-risk and high-risk pregnancies may be referred to the Hospital for such care.
- 3. The Hospital employs, contracts with or otherwise can furnish physicians with full operative privileges in obstetrics, gynecology, urology and general surgery appropriate for the care of such emergencies as may arise from procedures performed by PPGG or referrals from PPGG. Such physicians are available 24 hours per day, seven days a week as needed to staff the Hospital's emergency and operative facilities.
- 4. Upon presentation of such a patient to the Hospital's emergency room or obstetrical care program, the patient shall thereupon becomes a patient of the Hospital. The Hospital will be responsible for the treatment and medical management of the patient while in the Emergency Department and, if admitted to the Hospital, during the inpatient stay. Similarly, the Hospital will be responsible for the treatment and medical management of patients referred to the obstetrical care program. The Hospital will have no responsibility to any such patients prior to the patient's admission to the Hospital nor after discharge, unless directly related to care given while at the Hospital.
- 5. The Hospital will assume responsibility for collection of its charges and fees directly from the patient or third party payor known to be responsible for such charges and fees.
- 6. Upon the patient's consent the Hospital will advise PPGG regarding the medical condition of PPGG patients who are examined, treated or admitted by the Hospital for medical complications arising out of the services rendered to the said patients. The Hospital will further advise PPGG of the outcome of such treatments.

- 7. The parties agree and acknowledge that the acts performed by each pursuant to this Agreement shall not create, nor be construed to create, a legal relationship or agency, partnership or employment between the parties and neither party shall be liable or in any way responsible for the acts of the other party.
- 8. PPGG is responsible for any and all care that it provides to a party before that party becomes a patient of the Hospital and is responsible for any injuries that occur from any act, treatment or procedure performed, administered or omitted by PPGG, its staff members, agents or employees.
- 9. The Hospital is responsible for any and all care that it provides in the Hospital Emergency Department, obstetrical care program, operating suites, and/or inpatient units and is responsible for any act, treatment or procedure performed, administered or omitted by the Hospital, its staff, agents or employees. Neither party shall be responsible for injuries occurring as the result of any act, care treatment, procedure or omission of the other party.
- 10. This Agreement may be terminated by either party upon 90 days written notice to the other party. Absent such notice of termination this Agreement shall continue from year to year.
